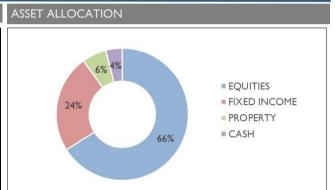
PORTFOLIO OBJECTIVE
