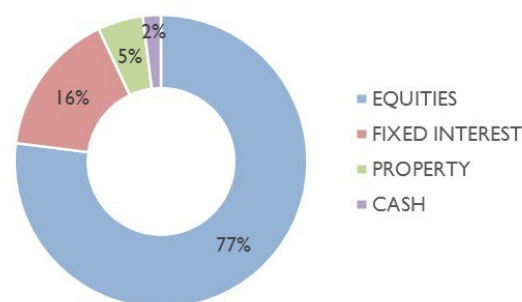

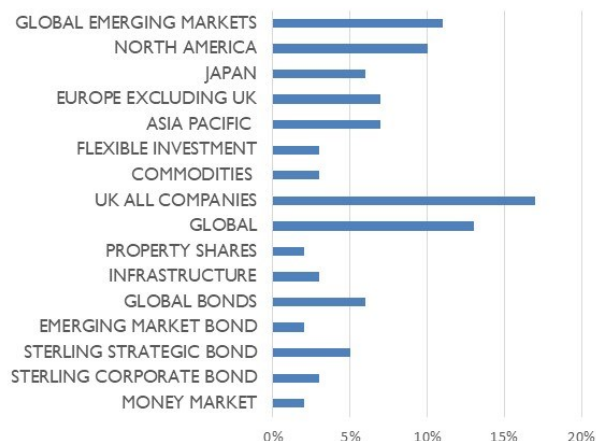

SECTOR ALLOCATION



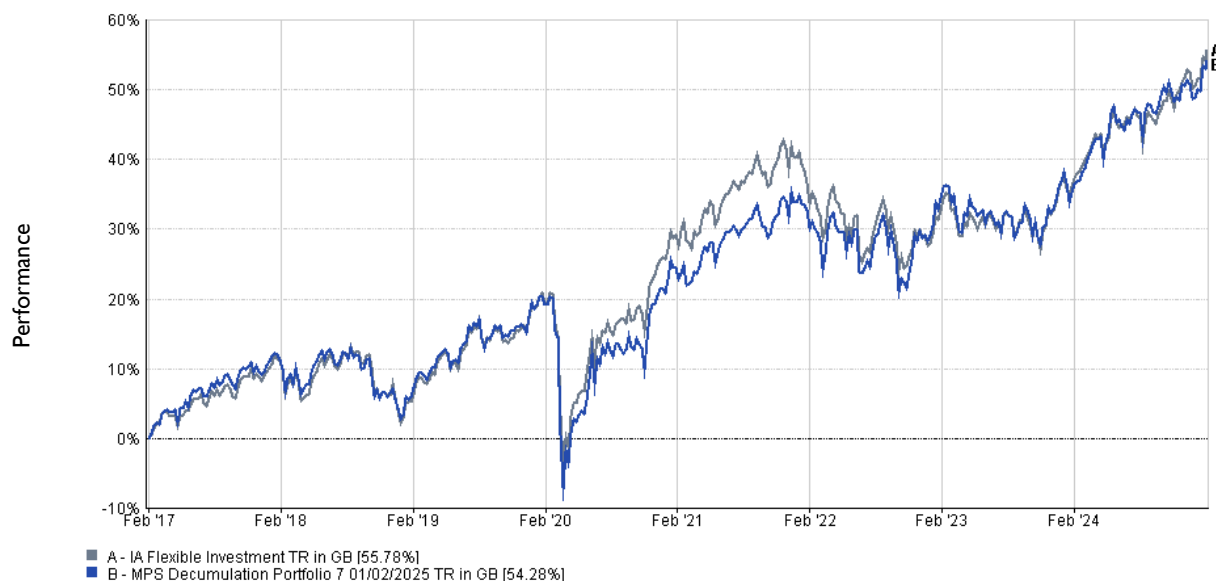

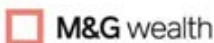
