Since inception in 2008, the Quilter PMS range has outperformed its benchmark across all risk profiles.

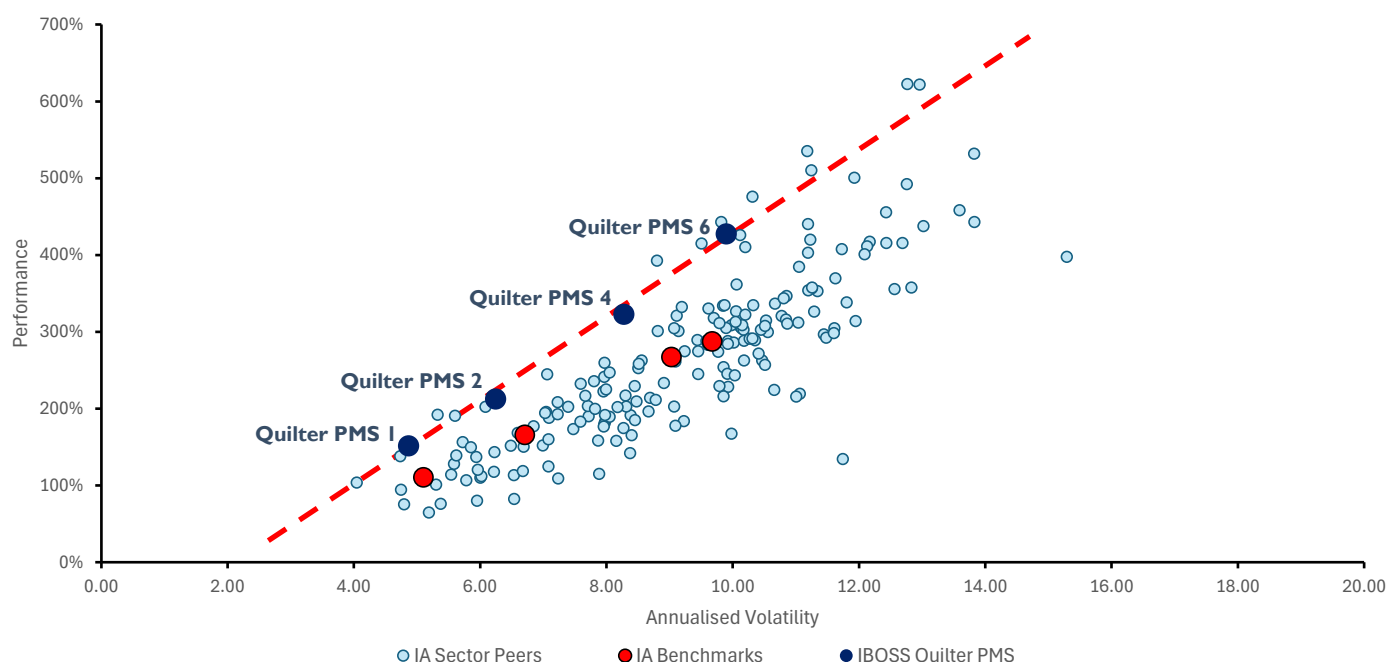
